Persons arrested or detained shall be brought promptly before a judge or other officer authorized by law to exercise judicial power and shall be entitled to trial within a reasonable time or be released. He said. It is restricted to the critical stages of the criminal prosecution where important rights of the accused may be irretrievably lost, such as interrogation or identification procedures involving the display of the accused person to one or more witnesses. It is therefore worthwhile to compare the position as stated by the European Court of Human Rights. In most countries, the police is entitled to arrest persons suspected of a criminal offence, either in fulfillment of a judicial warrant or by use of their general powers of arrest, most notably in cases where the suspect has been caught in the act of committing an offence.
